The effects of the rules will be to repeal unnecessary rules, update the Department's website, update coding from ICD-9 to ICD-10 to comply with federal regulations, updates the guidelines for terminology and coding to the most recent versions available, updates claim requirements and provide more information for providers and recipients via the Department's website.

Written comments and testimony must relate directly to the changes being proposed and must cite the specific rule number to which the comments are being directed.
