A public hearing will be held during a telephone conference at **(866) 410-8397** with a conference code of **7395895109**, on **May 19, 2020 at 2:00 p.m.**, to consider the adoption and amendment of proposed rules numbered

Chapters 20:06:12, 20:06:13, 20:06:19, 20:06:25, 20:06:26, 20:06:36, 20:06:59, and 20:06:60.

Explanation of Rules

Chapters 20:06:12, 20:06:19, 20:06:25, 20:06:26, 20:06:36, 20:06:59

The effects of these rule changes are to update the sources referenced in rule. The reason for adopting these rule changes is to ensure parties are referring to the most recent edition of the sources cited in the rules.

Chapter 20:06:13

The effect of this rule change is to update the Division's Medicare Supplement rules. These rules incorporate 2020 Medicare Supplement coverage amounts set by the federal government.

The reason for adopting this rule is to ensure that enrollees are given correct plan information and brings our Medicare Supplement rules into compliance with federal regulations. This will allow us to continue to regulate these types of plans and help consumers.

Chapter 20:06:60

The effect of this proposed rule change is to clarify the information required for insurance companies to complete the Corporate Governance Annual Disclosure provided by HB 1017, passed this last Session.

The reason for adopting the proposed rules is to enable the Division of Insurance to accurately identify and address risks posed by an insurance company's corporate structure.

Persons interested in presenting data, opinions, and arguments for or against the proposed rules may appear by calling into the hearing or by mailing them to the South Dakota Division of Insurance, 124 South Euclid Avenue, 2nd Floor, Pierre, South Dakota 57501. Material sent by mail must reach the South Dakota Division of Insurance by May 29, 2020, to be considered.

After the public hearing, the Division of Insurance will consider all written and oral comments it receives on the proposed rules. The Division may modify or amend a proposed rule at that time to include or exclude matters that are described in this notice.
