- (1) Daily charges for ~~an adult,~~ a person who is 16 years of age or older, ~~\$6~~ \$10;
- (2) Daily charges for a ~~youth,~~ child who is at least 6 to 15 but less than 16 years of age, ~~\$4~~ \$5;
- (3) One fair week's admission passbook (~~adult~~) for a person who is 16 years of age or older, ~~\$25~~ \$40;
- (4) One fair week's admission passbook (~~youth~~) for a child who is at least 6 but less than 16 years of age, ~~\$15~~ \$20;
- (5) ~~Vehicle~~ Daily charges for vehicle parking by the day, \$7;
- (6) ~~Vehicle~~ Fair week charges for vehicle parking for the fair week, \$30;
- (7) Camper package consisting of one camper permit, a family value admission pack, and one vehicle parking permit, ~~for the seven nights surrounding the annual state~~ including the dates of the fair, is as follows:
 - (a) Self-contained sites, ~~\$185~~ \$235;
 - (b) Electric-only sites, ~~\$265~~ \$315;
 - (c) Electric and water sites, ~~\$290~~ \$340; and
 - (d) Electric, water and sewer sites, ~~\$320~~ \$370;
- (8) Daily charges for camping at Gate 13 ~~is,~~ \$25 ~~per day~~ plus admission fees;
- (9) Supply truck or trailer ~~fee~~ for ~~the~~ fair week, \$100;
- (10) Service vehicle ~~fee~~ for ~~the~~ fair week, \$50;
- (11) Delivery vehicle ~~fee~~ for ~~the~~ fair week, \$55;
- (12) Prepaid family value pack ~~\$80~~ \$130 ~~for including four fair adult weekly~~ week passes for persons who are age 16 or older, \$130; and
- (13) One-day family admission pass ~~(up to consisting of 2 adult tickets for persons who are age 16 or older and 4 youth tickets)~~ for children who are 6 but less than 16 years of age, ~~\$20~~ \$35.
