A public hearing will be held in 123 W. Missouri Ave., Conference Room, on June 23, 2022, at 1:00 p.m. (Central), to consider the adoption and amendment of proposed Administrative Rules of South Dakota numbered

The effect of the rules will be to create a Registered-Trainee appraiser credential, clarify scope of practice of state-registered appraisers, update application contents for supervisory appraisers and Appraisal Management Companies (AMC), repeal outdated rules, revise exam requirements for certain credentials, establish rules for experience training programs, revise definitions, bring rules into closer alignment with federal rules.

The reason for adopting the proposed rules is to reduce barriers to credentialing that are beyond minimum federal requirements, create additional pathways to appraiser credentialing, make rules easier to read, understand and implement.
