The effect of the rules will be to define the minimum regulations necessary to maintain the health and safety of residents living in assisted living centers.

The reason for adopting the proposed rules is to revise language, correct spelling, update references, add definition of communicable disease, and add the ability for assisted living centers to stock naloxone for emergency use.

Persons interested in presenting amendments, data, opinions, and arguments for or against the proposed rules may appear in-person at the hearing, or mail or e-mail them to the South Dakota Department of Health, Office of Licensure and Certification, 600 East Capitol Avenue, Pierre, SD 57501 or by going to <http://rules.sd.gov>. The deadline to submit any such written comments for consideration by the Department is July 24, 2023.

After the written comment period, the Department of Health will consider all written and oral comments it receives on the proposed rules. The Department of Health may modify or amend a proposed rule at that time to include or exclude matters that are described in this notice.
