DEFINITION OF TERMS

5:01:01:01 Definitions.

5:01:01:01. Definitions. Terms used in this article mean:

- (1) "Designated city area," an area extending five miles beyond the municipal boundaries of Pierre, Sioux Falls, Aberdeen, Watertown, Brookings, and Rapid City;
- (2) "Direct route," the shortest practical route of travel between two points as determined by the official state mileage chart dated September, 1976, for in-state travel or the current Rand McNally Road Atlas mileage chart for out-of-state travel or as determined by standard map mileage for points not identified on the mileage charts;

- (3) "Employee," an individual working for the executive branch of South Dakota state government; an individual who by statute is made subject to this article;
- (4) "For-hire carrier," a carrier as defined in SDCL 49-28-1 that provides the services of a driver;
- (5) "Immediate family member," a spouse, child, or other relative who resides in the household of the employee;
- (6)(4) "Indirect route," a route of travel between two points which includes points not on the shortest practical route of travel;
 - (7)(5) "In-state travel," all official state travel within South Dakota;
- (8)(6) "Interrupted travel," additional travel for personal reasons which is not a necessary part of official travel;
- (9)(7) "Interview expense," lodging, meals, transportation, and any other expenses necessary to reimburse a prospective employee for travel from the prospective employee's home to the location of an interview for employment by the state of South Dakota. The term does not include any expenses incurred by the spouse of the employee;
 - (10)(8) "Motor vehicle," a motor vehicle as that term is defined in SDCL 32-5-1;
- (11)(9) "Out-of-state travel," all official state travel with a destination outside South Dakota;
- (12)(10) "Post of duty," the location where an employee is permanently assigned for work and permanently resides;
 - (13)(11) "Motor carrier," a carrier as defined in SDCL 49-28-1;
- (14)(12) "Standard map mileage," mileage listed on the current official South Dakota state highway map published by the state Department of Transportation;

(15)(13) "State vehicle," a motor vehicle owned by any agency of the state of South

Dakota;

(16)(14) "Terminal," an airport, railroad station, or bus depot when a common carrier is

used; an official or temporary duty station when private, pool, or other state-owned vehicles are

used by the traveler;

(17)(15) "Transportation expenses," the costs of all necessary official travel on regular

commercial airliners, chartered aircraft, privately owned motor vehicles, railroads, buses, and

other usual means of conveyance, including fares and such expenses incidental to travel while on

state business as baggage transfer fees, tolls, and taxicab fares.

5:01:07:02. Reimbursement limits for a private carrier. Except for professional

recruitment moves which are limited by SDCL 3-9-12 to one month's salary of the recruited

employee, reimbursement for allowable moving expenses incurred through a private carrier may

not exceed the cost of moving 11,000 pounds by a for hire carrier. The employee shall document

the moving expenses before reimbursement is made Repealed.

5:01:07:03. Allowable household moving expenses. Reimbursement of allowable
household moving expenses for state employees and for newly hired professional employees
applies only to expenses for moving household furnishings, appliances, and personal effects of
the individual and the individual's family. Allowable moving expenses include the following:

5:01:07:05. Allowable travel pay in addition to moving expenses. In addition to the moving expenses allowed by §§ 5:01:07:03 and 5:01:07:04, each state employee is eligible for mileage and per diem allowance for travel from the old post of duty to the new post of duty. Any newly hired professional employee may receive an allowance for travel expenses as provided by § 5:01:07:11 Repealed.

Storage expenses allowable under § 5:01:07:03 apply only to the belongings of the state employee's or newly hired professional's household and only in conjunction with moving expenses. Storage expenses will only be allowed for one public, bonded storage company per move Repealed.

5:01:07:07. Moving allowance for professionals. Moving expenses may be paid to any

person recruited and hired to fill a position which has been defined as a professional position by

the Board of Finance. The conditions are as follows:

(1) A professional is an employee receiving an annual salary equal to or greater than the

minimum annual salary for Grade GF as set forth in the pay grade schedules filed with the Bureau

of Human Resources pursuant to ARSD 55:10:11:02; and

(2) A written copy of the offer of employment for the professional position which contains

an offer of payment of moving expenses from the appointing authority must accompany the

application for moving allowance Repealed.

only when the individual is appointed to a full-time position by the appointing agency and when

the expenses have been approved by an authorized officer pursuant to regulation or resolution of

the agency's governing board or commission Repealed.

person entitled to reimbursement for moving expenses for professionals shall submit a household

moving application signed by the person, approved by an authorized officer of the board or

commission of the hiring agency, and accompanied by a statement of the monthly salary of the

individual Repealed.

5:01:07:10. Return of transit pay allowance. When an employee leaves the employ of

the state within six months following a move, the employee shall repay the state the cost of the

move paid by the state a prorated portion of the relocation allowance as provided below, unless

the employee was unable to continue due to illness or injury or was dismissed.:

0-6 months - 100%

6-12 months - 75%

12-18 months - 50%

18-24 months – 25%

0% 24 + months -

5:01:07:11. Allowable travel expenses for professionals. The travel expenses incurred by

any person recruited for a position on the professional staff, and by each member of the persons

immediate family, for one trip from a prior residence to a new assigned headquarter duty station,

is eligible for reimbursement to the extent permitted to a state employee under chapter 5:01:02.

However, the expense for mileage on a personal vehicle is limited to one vehicle and lodging is

limited to the allowance for occupancy of one room per night. Any reimbursable expenses under

this section shall be aggregated with moving expenses for purposes of the limitation on reimbursement as provided in SDCL 3-9-12 Repealed.
