PROPOSED RULES: 70:01:02:00 – Interstate Highways speed zone rule; and 70:01:02:27 – Fall River County speed zone rule.

Hearing Date: Thursday, July 27, 2023

FISCAL IMPACT STATEMENT:

The South Dakota Department of Transportation is proposing amendments to the following rules: **70:01:02:00 – Interstate highways speed zone rule; and 70:01:02:27 – Fall River County Speed Zone rule.**

The South Dakota Transportation Commission will be considering changes to the speed limit on Interstate Highway 90 in and around Sioux Falls and on U.S. Highway 385 in Hot Springs.

The purpose of the proposed rule changes is to enhance safety.

The proposed amendments to 70:01:02:00 will require removal of three signs at a cost of \$20.00 per sign and the installation of five signs at a cost of \$100.00 per sign, resulting in a total cost of \$560.00. This work will be performed by the department's maintenance forces. The proposed amendments to 70:01:02:27 will require the removal and replacement of two signs at a cost of \$265.00 each, for a total cost of \$530.00. This work will be done as part of the current reconstruction project in Hot Springs. The removal and replacement cost of \$265.00 per sign is at contract prices for the reconstruction project. The total cost of the amendments to 70:01:02:00 and 70:01:02:27 will be \$1,090.00.

FISCAL NOTE SUMMARY: The South Dakota Department of Transportation will be the only entity of government financially affected by this proposed rule change.

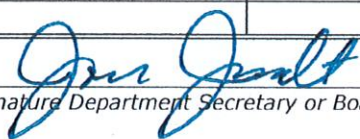
