### South Dakota Board of Nursing Notice of Public Hearing to Adopt Rules

A public hearing will be held at 4305 S. Louise Ave., Suite 201, Sioux Falls, SD, on October 10, 2023, at 10:00 a.m. (Central) and will be accessible via Microsoft Teams: <https://www.microsoft.com/en-us/microsoft-teams/join-a-meeting?rtc=1>, meeting ID: 212 359 045 234, passcode: iGLZww; or by teleconference: +1 605-679-7263, conference ID: 900 477 784#, to consider the adoption and amendment of proposed Administrative Rules of South Dakota numbered:

§§ 20:48:01:01; 20:48:04:01, 20:48:04:01.01, 20:48:04:01.02,  
20:48:04:01.03; 20:48:04:06; 20:48:04:06.01; 20:48:04:07.

The effect of the rules will be to revise and modernize the RN and LPN scope and standards of practice to be consistent with practice statutes in SDCL 36-9-3 and 36-9-4 and national standards of practice.

The reason for adopting the proposed rules is to update definitions and terms used; to modernize the scope and standards of nursing practice for the LPN and RN; to clarify supervision requirements of the LPN; to update and modernize the IV therapy tasks an LPN may perform, including the administration of blood components, after obtaining additional education and training; and to update the tasks and IV medications an LPN may not perform or administer.

After the written comment period, the South Dakota Board of Nursing will consider all written and oral comments it receives on the proposed rules. The South Dakota Board of Nursing may modify or amend a proposed rule at that time to include or exclude matters that are described in this notice.
