12:02:01:01. Definitions. Terms defined in SDCL chapter 1-21 have the same meaning when used in this article. In addition, terms used in this article mean:

- (1) "Fair," the South Dakota state fair;
- (2) "Annual state fair," the event starting the ~~Thursday~~ Wednesday before Labor Day and ending Labor Day;
- (3) "Secretary," the secretary of the Department of Agriculture and Natural Resources.

12:02:04:05. Admission fees. The admission fees for the South Dakota State Fair are:

- (1) Daily admission for an individual who is sixteen years of age or older, ten dollars;
- (2) Daily admission for a child who is at least six but less than sixteen years of age, five dollars;
- (3) One fair week's admission passbook for an individual who is sixteen years of age or older, ~~forty~~ fifty dollars;
- (4) One fair week's admission passbook for a child who is at least six but less than sixteen years of age, ~~twenty~~ twenty-five dollars;
- (5) Daily vehicle parking, seven dollars;
- (6) Fair week vehicle parking, ~~thirty~~ thirty-five dollars;
- (7) Camper package consisting of one camper permit, a family value admission pack, and one vehicle parking permit, for seven nights including the dates of the fair:
 - (a) Self-contained sites, ~~two hundred and thirty five~~ two hundred and sixty-five dollars;
 - (b) Electric-only sites, ~~three hundred and fifteen~~ three hundred and forty-five dollars;
 - (c) Electric and water sites, ~~three hundred and forty~~ three hundred and seventy dollars, and;
 - (d) Electric, water and sewer sites, ~~three hundred and seventy~~ four hundred dollars;
- (8) Daily camping at Gate 13, twenty-five dollars plus admission fees;
- (9) Supply truck or trailer for fair week, one hundred dollars;
- (10) Service vehicle for fair week, fifty dollars;
- (11) Delivery vehicle for fair week, fifty-five dollars;

(12) Prepaid family value pack consisting of four fair week passes for persons who are age sixteen or older, ~~one hundred thirty~~ one hundred sixty dollars; and

(13) One-day family admission pass consisting of two tickets for persons who are age sixteen or older and four tickets for children who are six but less than sixteen years of age, thirty-five dollars.

The admission fees listed in this section do not reflect special reduced admission prices resulting from promotional activities or group rates.
