- (1) Examination fee which includes the initial license, \$100 one hundred twenty dollars;
- (2) Examination retake fee, one test, \$60; two tests, \$70; three tests, \$80 ninety dollars;
- (3) Cosmetologist, nail technician, or esthetician license renewal fee, \$25 forty-five dollars;
  - (4) Temporary cosmetologist, nail technician, or esthetician license fee, \$\frac{\$6}{\text{six dollars}}\$;
  - (5) Instructor initial license fee and renewal fee, \$35 forty-five dollars;
- (6) Reciprocity, initial license, and waiver of examination fee, \$100 one hundred twenty dollars;
- (7) For certification Certification of a license issued pursuant to SDCL chapter 36-15 for a South Dakota licensee to obtain licensure in another state, or furnishing of other papers to another state or school, \$20 thirty dollars;
  - (8) Apprentice license fee, \$25 twenty-five dollars;
  - (9) Apprentice salon initial license and renewal fee, \$250 three hundred dollars;
  - (10) School initial license fee and renewal fee, \$300 three hundred fifty dollars;
  - (11) Student license fee, \$6 fifteen dollars;
  - (12) Salon or booth initial permit license fee, \$60 seventy-five dollars;
  - (13) Salon or booth license renewal fee, \$40 fifty-five dollars;
  - (14) Reinspection fee for failed salon, \$50 seventy-five dollars for each reinspection;
  - (15) License duplicate or replacement fee, \$5; and fifteen dollars;
- (16) Lapsed license penalty, \$20 for each year lapsed. fee, thirty dollars for each lapsed year; and

(17) Fee for the inspection of a prospective salon or booth at the request of the prospective

applicant, seventy-five dollars for each inspection.
