The effect of amending the rule is to update the Division's Medicare Supplement rules. These rules incorporate the 2026 Medicare Supplement coverage amounts set by the federal government. The reason for amending the proposed rule is to ensure that enrollees are given correct plan information and allow the Division to continue to regulate these types of plans to help consumers.
